

## **REPUBLIC OF BULGARIA**

#### SECOND ACTION PLAN OF THE REPUBLIC OF BULGARIA ON THE OPEN GOVERNMENT PARTNERSHIP INITIATIVE

#### **1. INTRODUCTION**

Bulgaria joined the Open Government Partnership Initiative in 2012. Bulgarian Government is committed to have an active role in developing a society based on more government transparency, citizen participation, responsibility, accountability and technological innovation by joining the initiative.

The participation of Bulgaria in the initiative is considered as an efficient instrument for cooperation and exchange of good practices with countries with recognised achievements in the field of open government.

During the initial stage of its participation in the initiative Bulgaria decided to focus its efforts on the achievement of more effective management of public resources and the improvement of the corporate responsibility. The country achieved good results especially with regard to publicity and higher level of accountability of public authorities. Publishing information concerning various aspects of the administration activities and the process of consulting draft of normative acts and strategic documents is a responsibility of the public authorities. Moreover, this is an increasingly recognized necessity that guarantees better results when policies are implemented. Some of the commitments included in the first action plan will be part of the Second Action Plan because of their added value to the society.

Another group of issues included in the first Action Plan of Bulgaria under the Open Government Partnership Initiative in particular those related to the promotion of corporate social responsibility seems to be areas with relatively limited effect mostly due to insufficient awareness of the society for the benefits of this approach and the fact that the businesses rather than the Government were the driving force of the process.

In the course of the dialogue with non-governmental organisations regarding the development of the Second Action Plan under the Open Government Partnership Initiative several areas were outlined where the Government shall focus its efforts for recognizing the principles of open government. New challenges should be faced. These are areas which have been insufficiently covered until now but increasingly become on the focus of public attention. The issue of open data is among these new priority areas.

Nevertheless this is a relatively new topic for Bulgaria, the need to promote the principle of open data in Government raised by active NGOs is acknowledged. The Government has committed to become active actor and boost the provision of open data by institutions. The potential of open data to generate new business opportunities is undoubted. The measures in the field of open data included in the plan are few but they represent first step necessary for introducing the idea of open data in Government as a tool to achieve the important principles of open government – transparency and citizen participation.

### 2. OPEN GOVERNMENT EFFORTS TO DATE

The Republic of Bulgaria officially joined the initiative in April 2012.

The Council of Ministers approved the First Action Plan by a Decree dated April 11, 2012 in relation to the membership of the Republic of Bulgaria to the Global Open Government Partnership Initiative. Aforementioned Decree assigned to the Secretary of the Council for Growth at the Council of Ministers to submit an Operational Plan related to the implementation of the commitments in the Action Plan. The Operational Plan was adopted by a decree of the Council of Ministers dated June 29, 2012.

The first plan was developed in cooperation with NGOs and covered the period until December 2013. The measures for implementation of the commitments in relation to the membership of the Republic of Bulgaria to the Global Open Government Partnership Initiative are in the following priority areas:

- More effectively managing public resources;
- Increasing corporate accountability and responsibility;

The overall coordination related to the development of the Action Plan was made interactively on the Public Consultations Portal in the Open Government Partnership section. http://www.strategy.bg.

Two new strategic documents and a package of amendments to the budget legislation have been adopted over the past year in accordance with the commitment to increase budget transparency. All these instruments have been consulted with the non-governmental sector and citizens. The improved regulatory framework creates the conditions required for transparent, sustainable and more effective management of public funds. The institutions publish regularly on their websites current data on their expenditures in order to meet citizens' expectations for transparency and information accessibility.

The Government has undertaken legislative changes to introduce a mandatory impact assessment of normative acts. This measure creates conditions for improved accountability and transparency in the work of the institutions and the administration when normative acts are developed.

Amendments and supplementations to the Public Procurement Act have been prepared aiming at full transparency and control in the tendering and execution of contracts and the facilitation of small and medium-sized enterprises' access to the public procurement market.

The introduction of e-government is a priority in State governance. Over the past year a package of projects has been implemented giving an impetus to e-government. Special attention is paid to e-health. The introduction of patients' e-files was launched in April 2013. A system for enhanced coordination and integration throughout the health services chain and for health data exchange is currently being introduced.

The Ministry of Economy and Energy has initiated the development of a new Mining Industry Development Strategy and a new Mineral Resources Act which will guarantee transparency in the management of mineral resources. These draft documents are intensively discussed in working group and by online consultations with the participation of Government, trade associations, non-governmental sector and citizens.

The dialogue between institutions, social partners, the NGOs and citizens' organisations is a priority in the work of the Government. During the second half of 2013 the sessions of the National



Council for Tripartite Cooperation which a body for consultations and debates between the Government, employers and trade unions were held on a regular basis. Public Councils headed by the relevant minister operates within each Ministry. Members of trade associations, non-governmental organisations and citizens' organizations participate in these Councils. More than 50 ad hoc working groups discuss important issues with the active participation of the businesses and citizens.

In accordance with the Independent Reporting Mechanism of the Initiative a researcher expert made a review of the implementation of the measures envisaged in the First Action Plan and recommended the inclusion of certain commitments in the Second Action Plan. The evaluation of the implementation of the First Action Plan has shown that Bulgaria has fulfilled almost all commitments made by the country. With regard to some of the commitments a recommendation was made to monitor their implementation or follow up them in the Second Action Plan (for example the Government Debt Management Strategy, the Strategy on Citizens' Organisations in the Republic of Bulgaria, the Mineral Resources Act, Amendments to the Access to Public Information Act).

The self-assessment report of the Action Plan was approved by Council of Ministers Decree, dated November 27, 2013. The Government assigned to the Minister of Regional Development to be responsible for the coordination and participation of the Republic of Bulgaria in the Open Government Partnership.

The Government will continue its work to overcome the challenges related to improving partnership between the administration and the civil society; improving administrative services and legal framework; and openness of the administration through improved access to information and data.

Measures launched with the first action plan will be implemented in the new one in line with the recommendations in the Independent Reporting Mechanism Progress Report, Bulgaria 2012–2013. Measures aimed at enhancing the process of civil society involvement in policy development will be implemented. Initiatives to increase budget transparency and to provide financial information in a user-friendly language will continue. Work will continue in the field of better management of natural resources; access to public information will be facilitated and the impact assessment of normative acts on small and medium-sized businesses will be improved, thus resulting in reduced administrative burden for small and medium-sized businesses and promoting economic growth.

#### 3. NATIONAL ACTION PLAN DEVELOPMENT PROCESS

Under the leadership of Minister of Regional Development an interministerial working group was set up to prepare the Second Action Plan of the Republic of Bulgaria.

Special section dedicated to the Open Government Partnership is located on the public consultations portal <u>www.strategy.bg</u> where the non-government sector and the civil society sent their proposals for commitments to be included in the Second Action Plan. Proposals could also be discussed in an online panel of the Open Government Partnership Initiative at <u>www.strategy.bg</u>. Meetings of the interministerial working group comprising representatives of the administration were held to discuss the Second Action Plan and the proposals made by the civil society. Joint meetings of representatives of the interministerial working group and representatives of the business, the non-government sector, the civil society and the local authorities were also organised. The draft plan was published on the public consultations portal <u>www.strategy.bg</u>. The proposals for



commitments sent by the non-government sector in the course of the preparation of the plan were also published there. A contact person from the Ministry of Regional Development was designated to liaise with the non-governmental sector during the preparation of the document.

The measures in the Second Action Plan are developed in line with the proposals of nongovernmental and citizens' organisations in the Republic of Bulgaria and these of representatives of the public administration, the recommendations in the Independent Reporting Mechanism Progress Report, Bulgaria, and the guidelines of the Open Government Partnership Regional Meeting for Europe, held in May 2014 in Dublin, Ireland.
