Improving open data management practices in Akhaltsikhe Municipality City Hall

Problem

Development of the internet and new technologies has played an important role in ensuring the openness of the governments and transparency of their activities. Innovative applications and platforms have given governments a unique opportunity to better understand the needs and requirements of their citizens. Therefore, the importance of public information and open data increases even more. Open data facilitates the development of civic monitoring mechanisms, improves public welfare and the efficient use of public resources. Akhaltsikhe is fully cognizant that the accessibility of data in public institutions, in addition to increasing the accountability of the government, can bring economic benefits. In order to improve the practices of open data collection, processing and publication, in 2019 Akhaltsikhe Municipality, with the support of USAID GGI and with the involvement of one of the leading local CSO's (IDFI), developed and approved an open data strategy and action plan. Effective implementation of the activities envisaged by the Action Plan is a priority of Akhaltsikhe City Hall. Akhaltsikhe Municipality aims to identify categories of relevant and important information for various stakeholders, especially for the private sector, which will be collected, processed and published in open data format on a permanent basis. Publishing information in open data format will significantly strengthen the transparency and integrity credentials of Akhaltsikhe Municipality.

Status quo

Currently the City Hall does not systematically collect, process and publish open data, even though Akhaltsikhe City Hall has an open data strategy and action plan.

Action

In order to improve open data management practices Akhaltsikhe Municipality City Hall will:

• Identify categories of relevant and important public information that are of interest to various stakeholders, especially to the private sector;

Collect, process and publish information in open data format on the website of the City Hall based on the defined categories.

How will the commitment contribute to solving the public problem described above?

Through effective implementation of the commitment Akhaltsikhe Municipality City Hall will significantly improve open data management practices. As a result, a level of transiency, openness

and accountability of the Municipality will be considerably strengthened.

What long-term goal as identified in your Open Government Strategy does this commitment relate to?

The Municipality strives to improve the relationship between the local authorities and the public and to strengthen public trust in governance by making ambitious steps towards more openness and inclusion. Increasing transparency of the work of the City Hall and its subordinate units is essential for achieving this long-term vision. While Akhaltsikhe Municipality City Hall has already made significant steps in this direction, this commitment will bring the process closer to the envisioned goal.
