Open Letter from Civil Society to Governments Participating in the Open Government Partnership (OGP) in the European Union

Dear OGP Participating Governments,

We, the undersigned European and global organisations, are writing to call on you to propose as part of your country's 2018 National Action Plan (NAP) a commitment to establish an open register on beneficial ownership for companies and trusts in accordance with and going beyond the recently adopted EU 5<sup>th</sup> Anti-Money Laundering Directive (AMLD5), and in line with Action Commitment #2 of the OGP Paris Declaration.

Anonymous companies underpin corrupt and criminal financial transactions. They can be used to move, launder and spend tainted money in the global financial system without being detected. Documents in the Panama Papers, for example, have shown how kleptocrats and their families used anonymous companies to secretly control state assets and purchase global real estate. For this reason, eliminating corporate secrecy is key to curbing illegal activities and contributing to the rebuilding of trust in European member states.

As of May 14, 2018, the EU <u>adopted</u> the AMLD5 to prevent terrorist financing and money laundering through the European Union's (EU) financial system. The revised Directive will strengthen the fight against corruption and money laundering in the EU and in developing countries by making public who owns and controls European companies. However, the new rules fail to extend full transparency to all structures operating in the EU, including foreign companies and most trusts<sup>2</sup>.

During 2018, 15 countries in the EU will be co-creating their NAPs<sup>3</sup>. This is an opportunity for these countries to include in their NAPs, a commitment for an ambitious implementation of provisions on beneficial ownership transparency in AMLD5. Since Member States will be allowed to go beyond the legal requirements set out in the text in order to take a more proactive stance on transparency, we call on governments to:

- Propose in their NAP the implementation of a public beneficial ownership register for discussion and approval as part of the co-creation process.

- Adopt the highest standards of transparency as part of the beneficial ownership transparency commitment, which includes:
  - o ensuring free and easy access to the public to registers of beneficial ownership information of companies;
  - o granting public access to beneficial ownership information of trusts;
  - o developing the beneficial ownership registers along open data principles, including by implementing the Beneficial Ownership Data Standard; and
  - o extending beneficial ownership transparency obligations to foreign companies to include those doing business or having a connection point to the EU.
- Propose in their NAP that the transposition of the 5th AMLD be carried out in an open and participatory manner in consultation with national stakeholders.

We look forward to working with governments participating in the OGP to ensure that the anti-money laundering directive in Europe meets its ambition and is effective in curbing the abuse of the corporate and financial systems for illicit activities.
