CONTENTS

Côte d'Ivoire expects a lot from the Open Government Partnership initiative to promote transparency and good governance in public affairs management, fight against corruption and Citizen's participation and technology innovation.

The country's commitment is reflected in its compliance with obligations incumbent on upon member countries. That's why, both at the level of documents produced periodically and at the level of participating in statutory meetings, Côte d'Ivoire respected OGP's deadlines and recommendations.

In this regards, Côte d'Ivoire participated in all OGP world summits and African regional meetings since it became a member in 2015, as it considers this initiative as an opportunity to share good practices in terms of open governance in the world. OGP is also a chance to promote accountability culture at all levels of responsibility.

For us, this is, above all, a source of hope for citizens in the sense that this partnership provides civil society and private sector with an additional means of expression on issues related to public affairs management.

That is why, through its active participation, Côte d'Ivoire shares experience while benefiting from peer members' good practices.

Locally, the OGP initiative outreach is underway. Various activities co-organized with civil society organizations throughout the national territory demonstrate the full adherence of citizens to OGP, with every time, participants' exceptional mobilization and attendance.

Various stakeholders input during the development of the first 2016-2018 National Actions Plan (NAP), lessons learned from the implementation of this plan, and useful recommendations from the independent assessment report have been of a precious help during the development of the 2018-2020 National Action Plan.

Co-creation is only possible with a shared will and vision between the stakeholders involved. Various supports, comments and recommendations received in spearheading the process are a source of additional encouragement to the Government of Côte d'Ivoire.

This National Action Plan is another way to express this common will and Ivorian actors' determination, that is to say, public administration, private sector and civil society to build together a more transparent Côte d'Ivoire based on more open governance, in Union Discipline and Labor.

INTRODUCTION

Côte d'Ivoire's membership to the OGP initiative in 2015 was followed by the development of its first National Action Plan covering the 2016-2018 period in compliance with OGP authorities recommendations. The formulation of this plan was possible with the determination of Ivorian Authorities, availability and contribution of civil society organizations, private sector, etc.

By the end of September 2017, the mid-term self-assessment report has been published and forwarded to OGP Support Unit. The formulation of this report received input from various actors, especially OGP Technical Committee members, commitment lead implementing agenbeies and members of the Ivorian OGP civil society platform. This provided an opportunity to assess our progress, to have a self-criticism about the work done by Côte d'Ivoire. This step mainly helped us draw the early lessons in order to continue the process smoothly.

The implementation of the first 2016-2018 National Action Plan was closed since June 30th, 2018.

Various lessons which emanated from the mid-term self-assessment have been supplemented by criticisms and recommendations of the assessment developed by the Independent Reporting Researcher who intervened early in 2018 under the Independent Reporting Mechanism.

Thus, the OGP Technical Committee (OGP TC), as an OGP inter ministerial operational body (CI-OGP) has drawn on this first experience and in compliance with its missions, to launch the development of the second OGP National Action Plan, the implementation of which covers the 2018-2020 period.

EFFORTS MADE BY GOVERNMENT OF CÔTE D'IVOIRE TO DATE

Before joining the Open Government Partnership, Côte d'Ivoire was already involved in various actions in line with the principles of this initiative (Millennium Challenge Corporation, Doing Business, African Peer Review Mechanism (APRM, Extractive Industries Transparency Initiative (EITI), etc.

These actions have been strengthened with the 2016-2018 National Action Plan, the implementation of which resulted in greater awareness and involvement of civil society organizations in the process.

In order to promote a more efficient administration geared to provide better service to the public, the Government of Côte d'Ivoire has identified modernized public administration as a priority. This willingness has led to the official launching of a portal for e-Administrative procedures (http://www.servicepublic.gouv.ci/) on September 28, 2017 by the Prime Minister.

In order to unite digital space of all Côte d'Ivoire universities and colleges, the Government of Côte d'Ivoire has established Côte d'Ivoire Virtual University (UVCI, http://www.uvci.edu.ci).

Its pedagogical model connects higher education with students in their family unit, so as to solve the problem of the increasing number of students on the university and business schools campuses.

Beyond the commitments of the first National Action Plan several actions have been carried out by the Government of Côte d'Ivoire to promote open government. This includes opening an on line citizen participation platform http://www.participationcitoyenne.gouv.ci/ to enable citizens of Côte d'Ivoire to directly contribute in improving public services by making proposals accordingly.

The same applies to tele taxation portal (https://e-impots.gouv.ci/) enabling tax payers to declare and pay their taxes on line.

Concerning the fight against corruption, the High Authority for Good Governance(HABG) has put on line statistics about asset declarations by high level officials, Ministers and Mmemners of Parliament, on its site since 2017(http://www.habg.ci/index.php).

There is also the Public Service Observatory (OSEP) which is a tripartite committee for permanent monitoring. It helps improve the quality of public service and allows to assess the effectiveness and transparency of public service through listening, user's' complaints mechanism and follow-up of their processing.

The One Stop Shop for Foreign Trade (GUCE), https://guce.gouv.ci/?lang=fr simplifies and harmonizes trade procedures, fast processing of trade operations, trade facilitation as well as a materialization and travel reduction for various external trade actors..

2018-2020 NATIONAL ACTION PLAN DEVELOPMENT PROCESS

The 2018-2020 National Action Plan formulation process was, like the preceding one, prepared with the participation of several actors. This was done through different activities carried out in close relationship with civil society organizations and Ivorian Civil Society Platform for Open Government Partnership in Côte d'Ivoire.

The preferred approach is built upon training sessions for public consultation actors and discussion workshops between stakeholders.

Training Sessions

Two training sessions were held from 11-13 April and from 24-25 April 2018 for various actors involved directly in the formulation of the second National Action Plan.

The first training session targeted trainers, that is, persons selected to conduct public consultation sessions for the development of the National Action Plan. These persons were representatives of public administration, and those of the civil society in particular, members of Ivorian Civil Society Platform for OGP. The second training session specifically focused on the use and management of the public consultations digital platform (**cp.ogp.gouv.ci**), with the same target persons.

These trainings were delivered under the Support Project to Francophone Open Governments (PAGOF), with the financial support of French Development Agency (AFD).

The technical assistance provided within this context was ensured by French Agency for International Technical Cooperation (Expertise France) and French Media Development Agency, CFI.

Public consultations

Assignments for public consultations during the development of the second National Action Plan were jointly conducted by the OGP Technical Committee and the Ivorian Civil Society Platform. Public consultations began early in 2017, through five (05) towns in Côte d'Ivoire, namely, Bondoukou, Agnibilékro, Aboisso, Daloa and Yamoussoukro. They were strengthened and completed by those carried out in 2018 in Bongouanou, Gagnoa, Odienné and Abidjan.

Furthermore, in order to involve the maximum of stakeholders, public consultations in Bongouanou were attended by the following surrounding communities: Anoumaba, Andé, Assié-Koumassi, Abongoua, Arrah, Kotobi and M'Batto.

Likewise, in Gagnoa, ccomminities of Oumé, Ouragahio, Guibéroua and Diegonéfla participated in the activities.

The Abidjan step has helped to consolidate all the other consultation results, which helped to highlight major problems and identify potential lead implementing agencies.

The main target of these meetings was to involve and get the Ivorian Civil Society participate in the conduct of the OGP process in Côte d'Ivoire and more specifically to (i) provide participants' awareness on OGP process (ii) debate over themes of interest and (iii) collect Civil Society's opinion and concerns with a view to develop the 2018-2020 National Action Plan.

These different consultations were followed by the on-line availability of the public consultations digital platform on June 11th, 2018. https://cp.ogp.gouv.ci/. Contributions on this platform ended on July 11th, 2018. https://cp.ogp.gouv.ci/. Inputs on this platform ended on July 11th, 2018.

- Establishment of commitments

Three activities were achieved following the public consultations, namely the two-day workshop held on 6-10 August 2018 in Abidjan and meetings of OGP-TC with lead implementing agencies.

- The first day of the workshop brought together members of the Civil Society Platform who worked on themes collected during various 2017 and 2018 public consultations in order to translate various preoccupations collected in different visited towns into commitments proposals.
- The outcomes of this first day provided a basis for the discussions during the 10 August 2018 activity; it was attended by OGP-TC, Ivorian Civil Society Platform and structures supposed to bear the second plan commitments.

This activity mainly enabled the participants to analyze the commitment proposals in the light of OGP principles and ensure that they could align with Côte d'Ivoire's National Development Plan for projects covering 2018-2020 period.

- At the end of this two-day activity, potential commitments holders were identified; which enabled the Technical Committee to initiate direct and regular meetings with them.

These sessions enabled various actors to agree on expected information in the different commitments, allowing OGP-TC to provide itself with various commitment projects for the preparation of the National Action Plan draft.

- Preparation of the Action Plan draft

The National Action Plan draft development sessions were jointly carried out by OGP-TC, commitment holders, and the Ivorian OGP Civil Society Platform in a workshop held in Abidjan on, Thursday September 27th, 2018.

This activity enabled the participants to agree on the commitment projects and mainly ensure that they are relevant and achievable.

- Pre-Validation of the National Action Plan

The plan prevalidation workshop bringing together the OGP-TC, commitment holders and OGP Ivorian Civil Society Platform was held on October 17, 2018 following a 15- day period granted to various stakeholders especially to the civil society to make comments to the Action Plan draft.

- Focal areas of the 2018-2020 National Action Plan

This National Action Plan is in line with the National Development Plan dynamics (2016-2020 NDP) the first strategic focal area of which is dedicated to the strengthening of the quality of institutions and governance.

The quality of the institutions is necessary to ensure their credibility. Open and credible institutions are a source of stability because they sustainably build confidence between the State and citizens.

In the management of these matters, taking into consideration several issues is essential in the search for quality and transparency as shared aspirations.

This is the reason why this National Action Plan emphasizes on access to information, budget transparency, plurality of expression, education, fight against corruption, open data, health, and strong citizen involvement as well.
