# I. Introduction

The values and principles of Open Government are a priority that underpins the strategy of the Ministry of Administrative Reconstruction. Openness, inclusiveness and accountability are fundamental principles which are the cornerstone for the development and pursuit of national policies.

The culmination of our explicit and clear commitment to responsible open government is the active and continuous, since 2012, participation of the Greek Government in the International Cooperative Initiative of the Open Government Partnership (OGP) and the adoption of its values, through the development and implementation of the National Action Plans on open government.

At this stage and in cooperation with Civil Society bodies, the Fourth National Action Plan for Open Government for the period June 2019 - May 2021 has been developed.

Following a positive outcome that the country recorded in the Open Data agenda in international fora (<u>European Data Portal Report 2018</u>) the National Action Plan focuses on this specific domain, with the line Ministries as main actors.

The commitments further promote open access and re-use of documents, information and public sector data, which is a priority for the Greek public administration, with a view to bringing significant benefits to the society, the economy and the public administration.

Our participation in OGP is another opportunity for the Greek Government to launch an inclusive platform for an effective cooperation with civil society towards its meaningful involvement in monitoring the implementation of open government policy commitments.

#### **Governance model of the National Action Plan:**

The designated representative of the country in the OGP international cooperation initiative coordinates the promotion of the national policy on open government and the implementation of the National Action Plan.

A single management model of implementation is a prerequisite for achieving the objectives of the National Action Plan. The aim is to monitor and coordinate implementation of individual commitments in order to respect the timetable for implementation, and to update or amend the commitments undertaken where appropriate.

The Ministry of Administrative Reconstruction is responsible for the coordination of implementation of the open government commitments through the Transparency and Open Government Department, which is responsible for monitoring and coordinating issues relating to Greece's participation in the OGP. The actions include:

- Drafting and monitoring the implementation of the Open Government Action Plan, in line with the Charter of the Open Government Partnership Initiative, OGP (www.opengovpartnership.org) and the possible update of the Plan with new commitments,
- Cooperation with the bodies which have undertaken commitments under the Open Government Action Plan
- Cooperation, interaction and consultation with civil society actors active in the objects of open government,
- Cooperation with international organisations and bodies on open government issues
- Cooperation with the National OGP Representative to fulfil the country's obligations to OGP
- Representation of the country in OGP actions, following the consent of the National Representative

## II. Drafting Procedure for the National Action Plan

On 16 April 2019, the drafting procedure of the 4<sup>th</sup> National Action Plan for Open Government was launched at a meeting with representatives of bodies, which took place at the Ministry of Administrative Reconstruction. A set of initial proposals and ideas for further discussion and processing has been formulated during the event.

On 18 April 2019, a meeting with Civil Society representatives was organised under the coordination of the Ministry with a view to drawing up the initial proposals.

All the initial commitments have been presented in an open consultation procedure in the period between 7.5.2019 and 14.5.2019, with a view to ensuring the participation of the wider public in the process.

The OGP Greece Ideathon was an initiative of the Ministry of Digital Government, taking into account the special circumstances caused by the COVID-19 pandemic, to facilitate co-creation of new commitments aimed at improving the 4th National Action Plan for Open Government. A total of 15 proposals were submitted by 11 civil society organizations, companies and citizens. For the utilization and adoption of the proposals, a series of meetings were held with the competent Ministries, the Parliament and the National Telecoms Regulatory Authority -EETT and several of them were accepted, presented on Dec 17, in a workshop attended by more than 100 representatives of Public Administration and Civic Society organizations, and are incorporated into the updated plan.

#### **MINISTRY OF SPORTS AND CULTURE/ SPORTS SECTOR**

**COMMITMENT**: Creation of a unified platform of anonymous and confidential reports (whistleblowing platform) so as to promote integrity in sports.

WHICH PUBLIC ISSUE DOES THE COMMITMENT ADDRESS? Many forms of corruption and deception, doping and physical / sexual abuse of adults and minors, bullying, fan violence, financial crime, match-fixing, abuse of power, bullying and other unfair practices seem to be endemic in sports. The issue of irregularities in sport is a "hidden" problem and therefore it is difficult to "measure" the current situation and quantify the effects.

#### WHICH IS THE PROPOSED COMMITMENT?

Development of a secure platform for confidential and anonymous reports of incidents of irregularities in sports. Promoting a culture of integrity in sports through innovative applications and integrating them within the reporting platform.

- Citizens, through datasets, will gain access to information (website available). Published datasets will become a useful tool for citizens' access to culture and motivate productive forces to develop IT applications of cultural interest.

- Distribution of similar sets in different ways by various Services: By set grouping and homogenizing the goal becomes a common policy of allocating similar data, so that every citizen becomes aware of how and under which conditions it is possible to obtain the data one needs.

Support and Register of Farmers and Agricultural Holdings (MAAE) which, due to its competence, has the final say in the approval of the data that will available.

The **first milestone** for the implementation of the above commitment is the imprinting of the new anonymized data of the Register, in the decision of the OPEN DATA of the Ministry of Rural Development and Food for the year 2021, adjusting the description of the specific data set to in an adequate and clear form their increase, compared to the previous year.

The second milestone is posting of the updated and enriched register, in the open data of data.gov.gr

# Title: Amendment of the EETT's Regulation about Quality Indicators of Electronic Communications Services and publication of open datasets

#### Short description

Since 2008, EETT has been publishing results of Quality Indicators (QI) of electronic communications services provided to the public. The QI Regulation (EETT Decision No. 480/017/13-05-2008, as amended by EETT Decision No. 621/011/27-09-2011, Government Gazette 2417/B/ 2011) determines the content and the form of the information to be published as well as the means and frequency of publication. The results of the QIs are produced by the providers on a semi-annual basis in the form of excel files, based on templates for each category of indicators issued by EETT. The current EETT initiative concerns the amendment of the QI regulation and the publication of open datasets.

#### **Public issues addressed**

EETT's QI Regulation needs to be amended to take into account the relevant changes in the rest of the regulatory framework, the relevant technological developments, as well as the experience from its application so far. The main objectives are to provide detailed information on the level of customer service (initial connection, failures, telephone support), as well as the publication of the results in the form of open datasets for their further use by citizens or other interested parties.
