Bojonegoro Institute (BI), is a civil society organization established in 2005, and engaged in research, advocacy, public policy initiation and assistance. To date Bojonegoro Institute concerned with local issues, such as local governance, transparency of oil and gas, public information services, poverty alleviation and budget transparency.

Some of the Bojonegoro Institute achievements along with Bojonegoro Regional Government, such as initiating and formulating the Regional Regulation (Perda) on Transparency Governance of Oil and Gas (Oil and Gas), Local Economic and Sustainable Development, Poverty Alleviation, Oil Fund and Public Information Disclosure Services. On the issue of Public Information Disclosure, for example, the Bojonegoro regional government took Bojonegoro Institute to formulate a decree (Perbup) Number 40, 2014 on Guidelines for Information and Documentation Services in the Government of Bojonegoro Area. In addition, it is also involved in the formation of Documentation and Information Management Officer (PPID) in each Working Units (SKPD), preparation of The List of Public Information (DIP) and increasing the capacity of public information services.

Bojonegoro Regency Government also makes some of the research results of and assessment of public information services conducted by Bojonegoro Institute as an evaluation and feedback for improving service performance information in each Working Units (SKPD). In addition, at the beginning and the end of the year we do an access test in Working Units (SKPD), access test results were used by Bojonegoro Regency Government for improvement evaluation material in the information services of Working Units (SKPDs). Up to now, Bojonegoro Regency Government has had some complaints aspirations or input solicitation media services manifested in online and offline information, among others LAPOR (Online People's Complaints Service), SMS Bupati and more integrated gateway through SIAP LAPOR (Integrated Online Aspirations People Complaints System), Friday Dialogue and Documentation and Information Management Officer (PPID) in each Working Units (SKPD).

With the varieties of complaints aspirations media and information services, which are provided by the Government of Bojonegoro has increased public participation in accessing information and aspirations. As experiencedby Advocacy Team of Bojonegoro Institute who ever using Friday Dialog and LAPOR to oversee the transparency of oil and gas and the problem of environmental damage around the area of oil and gas, which quickly responded and acted upon a follow up by the District Government.

In relation with the participation of the Bojonegoro Regency Government in the Open Government Award, Bojonegoro Institute strongly supports the step. The support we provide for the commitment, consistency and maximum efforts of Bojonegoro government in order to achieve democratic, transparent, accountable and participatory governance.
