IDFoS is a civil society organization established on July 5, 1999 with the main activities such as Community Empowerment, Policy Advocacy; Research and Development of Public Information. Within recent five (5) years IDFoS have along with Bojonegoro Regency Government has initiated policies that provide a space for civil society to be involved in development management in Bojonegoro. One of them through the establishment of Perda No. 5, 2015 on Corporate Social Responsibility (CSR) which the formulation involves IDFoS and Civil Society Organizations (CSOs) that are members of the Civil Society Alliance for Prosperity (Gemati, Fospora, Inspektra, PMII Bojonegoro Branch, SEC, Fatayat Bojonegoro Branch, NU Bojonegoro Branch, IMM Bojonegoro Branch, Lima 2B, OPI, Ploso jenar).

The Regional Regulation (Perda) on CSR provides shared space between Bojonegoro Regency Government, CSOs and the private sector in planning, implementing, supervising, and evaluating Corporate Social Responsibility (CSR). The advantages of the enactment of this regulation uch as, reducing the double budgeting program (the program of private sector and government programs), as well as the growing involvement of the development for the

private sector and civil society in Bojonegoro.

Other initiation conducted by IDFoS long with Civil Society Alliance (Inspektra, BI, Elpamas) and the Government of Bojonegoro is to encourage the publication of the decree on Guidelines of Civil Society Organizations (CSOs) Partnership and the Development of Bojonegoro Government. The essence of Perbup were to ensure the involvement of Civil Society Organizations (CSOs) in Bojonegoro policy development. This refers to Perbup Bojonegoro on the medium-term development plan (RPJMD) especially in Bojonegoro development pillars, namely social capital.

Moreover, it also every Friday morning, Bojonegoro regency administration were routinely monitoring and evaluation (M & E) for all the programs and follow up on complaints from the public through the media services (PPID, Lapor, Friday Dialog). Monitoring and evaluation attended by multistakeholder which

also open to the public, including civil society organizations (CSOs).

Furthermore, IDFoS support Bojonegoro governments in Open Government Award. The support we provide for the commitment, consistency and maximum efforts of Bojonegoro Government in order to realize a democratic, transparent, accountable and participatory governance.
