Three-Year Implementation Plan

Some of the feedback we have heard from the SC includes:

- Include more prominently within the narrative any changes and shifts in strategy, clear overall results to be achieved, what is meant by “**stronger OGP**”, as well as indicate what, if any, activities we will stop doing.
- Consider the 3YP as an opportunity to develop a set of common indicators to help benchmark country performance and help bridge some of the current disconnect between the open gov community and overall transparency community.
- There is a need to interlink different components such as synergies/overlap between commitments, themes, countries.
- A 2020 work plan + budget should be integrated within the final 3YP being tabled for approval at the February SC meeting. Also consider a three year budget framework. This will also help think through where additional staff capacity is needed and what can be prioritized based on resources available.



- Integrate within the services addendum what the benefit is for governments to be part of OGP and provide more context and make it easier to understand without too much ‘insider’ talk. The discussion underlined that we can share country examples to show how SU is presenting value propositions for whole-of-government buy-in for open government.
- Pull out more clearly the role of civil society throughout.
- Additional clarity within the document on how priority countries are selected and what services they receive would be beneficial, and where locals fit in.
- OGP should strive to collaborate with government schools to develop open government resources, strengthen the philosophy behind open government, and enable governments at all levels to develop open government reforms not necessarily only within OGP action plans in an attempt to make it the movement more sustainable.
- There should be a way for the wider open gov community to engage with the process, and build ownership for the plan. There should also be a clear response matrix to see what feedback is given on the plan, and how it was incorporated.

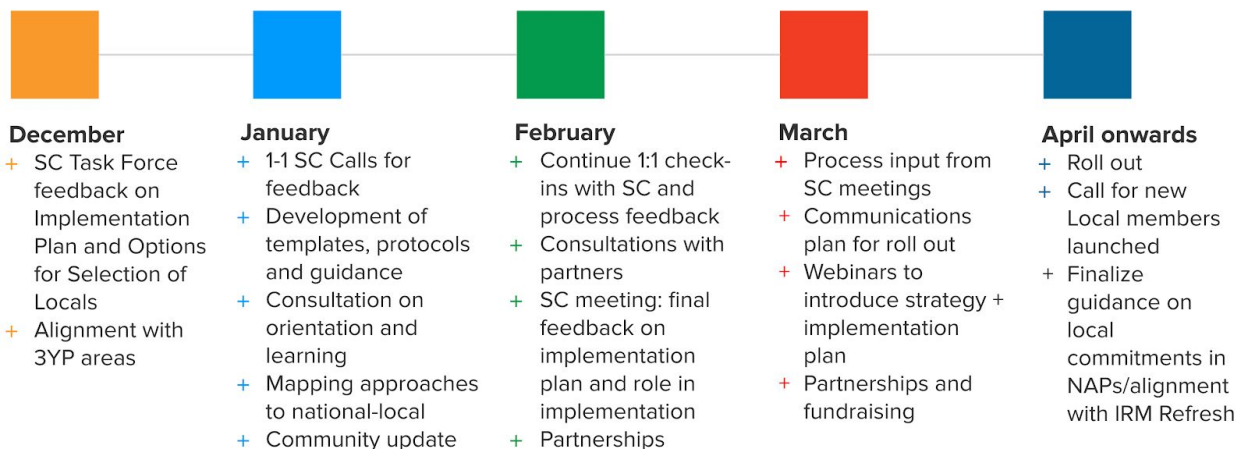
Support Unit Clarifications and Actions Items

Local Strategy

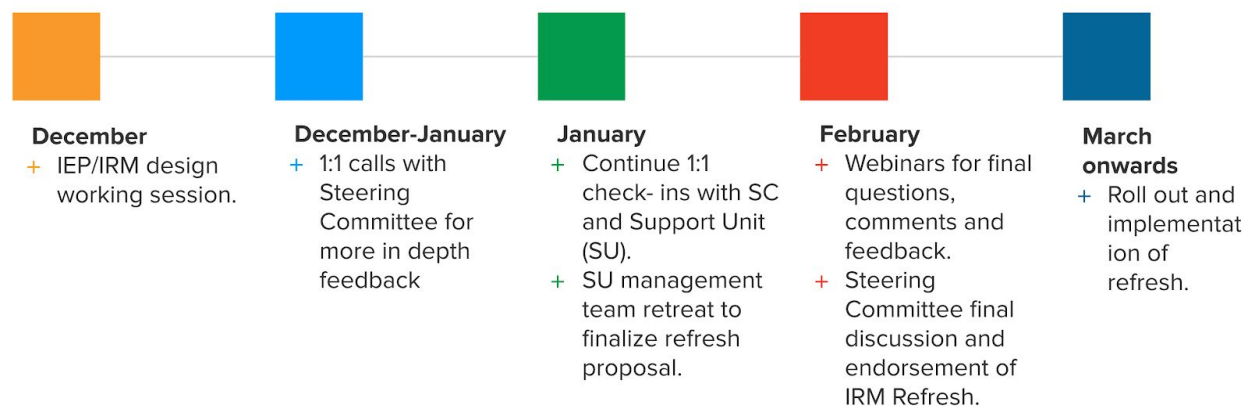

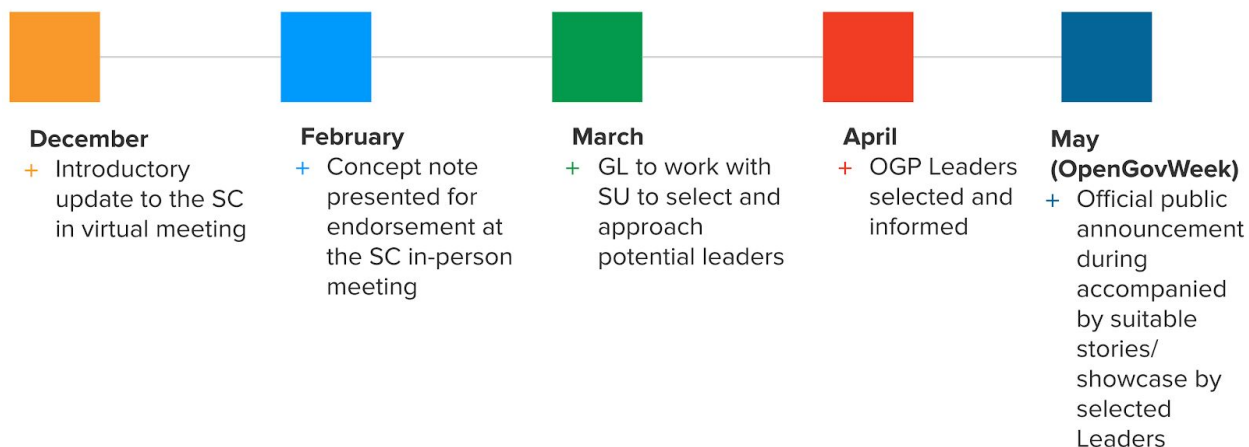


OGP Leaders and Leaders Network

Criteria and Standards - Update on Trinidad and Tobago

- **Trinidad and Tobago** has been under inactive status since December 2018. As per the [Steering Committee resolution](#), Trinidad and Tobago had until 5 December 2019 to submit and action plan or work with Criteria and Standards Subcommittee on a timeline to re-engage in OGP. Having failed to do so, Trinidad and Tobago has been removed from the list of OGP participating countries effective 6 December 2019.
