Expression of Interest (EOI) Filing Requirement:

This expression of interest must be filed jointly by government and non-governmental stakeholders*. It is important to note that there should be two (2) submissions per local jurisdiction:

- one (1) submission from the government stakeholders
- one (1) submission from the non-governmental stakeholders.

It is expected that government and non-governmental stakeholders communicate regarding this joint filing prior to both submissions. Please note that both submissions (government and non-governmental) must reflect the same exact information on the "Local Jurisdiction Information" page of this form. Below you will find all of the questions that will be asked in the following form within the aforementioned link.

*OGP traditionally refers to non-governmental stakeholders as civil society. However, local contexts differ and the language used to describe non-governmental stakeholders varies. Examples of non-governmental stakeholders are: civil society organizations, community organizations/groups, citizen councils/groups, citizen-led social movements, local chambers of commerce, universities, youth councils/groups, etc.

Expression of Interest Form Questions:

 - Non-governmental stakeholder
