The Single Platform initiative, which is a system put in place to allow the local community and stakeholders to interact with The Great Salt Municipality and track its services through web platforms, or through the use of a mobile application. Our detailed guide of the services, procedures, and timeframe for each option that the Great Salt Municipality presents to its local community and stakeholders. The availability of numerous paths in and around The Great Salt Municipality that cater to people with special needs. These paths ease the process of transportation within our jurisdiction and the process of reaching our offices which will encourage citizens including the most vulnerable such as the physically impaired citizens to participate in meetings and discussions.
