FoN is the OGP Local civil society partners for Sekondi-Takoradi Metropolitan Assembly (STMA) and Shama District Assembly (SDA) in the Western Region of Ghana.

Since 2019, FoN we have been working with the AnDA in promoting social accountability and active citizenship, and particularly in the area of resource management. We have collaborated with the AnDA to empower communities to effectively engage with the Assembly and relevant state agencies to address issues that affect citizens in fisheries livelihoods, coastal lands protection, sand mining; and also service promotion of access to low-cost financial services, public health and education. We have also facilitated development of their capacities on the planning, budgeting and monitoring cycles of coastal land-use and fisheries. Currently, we are working on an initiative to stimulate effective participation of stakeholders in revenue generation in the fisheries sector (main occupation of inhabitants and the potentially the biggest source of internally generated funds to AnDA) and how to maximize revenue for projects and programs to effectively benefit all residents especially women and children who are the targeted primary beneficiaries to achieve gender equity and economic empowerment.

We believe in the AnDA which has enthusiastically demonstrated commitment towards public accountability, transparency and civic participation in governance which are in line with the OGP values, thus joining the OGP Local 2022 cohort will provide the opportunity for the Assembly to share their experiences and learn from others in deepening transparency, accountability and good governance.
