I am pleased to greet you and formally express the interest we have from the state government in the local program 2022 of the Open Government Partnership (OGP). As per program guidelines, in previous years, we have successfully participated in this program hand in hand with non-government organizations.

We are very excited to continue with the action plan, and I am delighted to renew my commitment to the principles of Open Government to deepen our collective learning and guide the way we govern.

In this administration that I am honored to lead, we work on transparency, access to information, citizen participation, accountability, and anti-corruption strategies. To this date, the commitments and activities that have been generated within the framework of open government are proof that we champion the public agenda to continue standardizing processes of public decision-making with a citizen perspective.

In Quintana Roo we have come a long way with open government exercises and practices, some at state level and others at municipal level. In August 2022, we celebrated the 5th "Glosa Ciudadana" (accountability program) on open government and sustainable development, a program where I signed a commitment to continue developing and grow civil participation and accountability. The lessons learned make us recognize that we need to follow up on an action plan, as an articulating element to unite all the open government actions that have emerged in the state and that are an expression of the diversity and multiculturalism that characterizes us in its eleven municipalities and their communities.



The challenge for this administration is to institutionalize the open government model and action plan with a robust legal framework. To this end, the Government Secretariat and the Controller's Secretariat are the agencies in charge of executing the 2022-2027 Development Plan, which includes strategies and a specific program to develop this model. This is planned to be executed hand in hand with civil organizations and academics; specifically, with Ciudadanos por la Transparencia A.C., Bios Participación Política y Desarrollo A.C., COPARMEX Quintana Roo, Colectivo por el Impacto Social A.C., Universidad del Caribe, University of Quintana Roo, amongst other universities and organizations.

The common agenda on which we are working contains the following topics:

- Fiscal transparency to promote proactive transparency, civilian participation, and accountability in local education, environment, and gender exercises.
- Co-creation with the public for innovation and legislative initiative to grant autonomy to the Public Registry of Property
- Quintana Roo 2050 Sustainable Development Plan to communicate participatory planning.

We hope to develop an action plan for the next five years and share our experience with the local members of OGP.
