Midterm Review: Jordan 2021–2025

#### **Overview**

In December 2021, Jordan submitted a four-year action plan to the Open Government Partnership (OGP). At the midpoint, Jordan took stock of the action plan's progress and context after two years of implementation. Based on this reflection, Jordan submitted a refreshed action plan in August 2024. This IRM document reviews the refreshed action plan, the status of implementation at the midpoint, and alignment with the minimum requirements under the OGP Participation & Co-Creation Standards.<sup>2</sup>

The refresh process for Jordan's fifth NAP was participatory and inclusive. The Open Government Unit (OGU) in the Ministry of Planning and International Cooperation (MOPIC) launched the process in April 2024 with an open call for public submissions to the refresh process. Joint working groups reviewed and finalized submissions. OGU published outputs of the refresh process on the Jordan OGP website.<sup>3</sup> In the future, the IRM recommends that OGU publish the timeline for the entire process with information on opportunities to participate at least two weeks before it commences.

No commitments were added or significantly amended. The OGP Point of Contact noted that this was in part due to the fact that development of the sixth action plan was expected to begin within a year of the refresh.<sup>4</sup> However, new milestones were added to Commitments 1, 2, 4 and 5 on e-participation, integrity standards, and youth policy. The amendments build on existing milestones and align with IRM recommendations in the Action Plan Review to ensure implementation is participatory and endorsed by civil society organizations.<sup>5</sup>

Government ministries, civil society, and independent public institutions met during the first two years to discuss implementation progress and the refresh.<sup>6</sup> Jordan's OGP multi-stakeholder forum (MSF) met annually in 2023 and 2024. OGU explained that the forum did not meet in 2022 as the search for funding opportunities was ongoing and no substantive progress had been made.<sup>7</sup> However, annual meetings with a wider group of government and civil society actors were held to review the plan. Additionally, smaller groups periodically convened to discuss specific commitments. The IRM recommends the MSF to meet at least every six months to collectively strategize around implementation challenges and resource mobilization.

Jordan's fifth national action plan (NAP) is on track to be completed by June 2025.8 All six commitments are progressing with the majority of original milestones completed.

- In July 2024, Jordan was removed off the Financial Action Task Force (FATF) grey list
  after almost three years on it since October 2021.9 The government has planned
  measures to stay off the list, including new milestones in Commitment 1. As
  recommended in the IRM Action Plan Review, several activities are being implemented in
  collaboration with civil society organizations (CSOs).
- Implementation of Commitment 3 on mainstreaming gender in public service has advanced beyond the initial milestones.
- Commitments 4 and 5 faced a lack of funding for their foreseen online platforms. Funding
  was secured for Commitment 4 but was still pending for Commitment 5 at the time of
  midterm review.
- In the Action Plan Review, the IRM evaluated Commitment 6 on public participation in capital investment projects to have the greatest level of ambition. Progress has been

made towards creating channels for local civic participation. However, no projects had been piloted by December 2024.<sup>10</sup> The IRM recommends that, at minimum, one project is piloted by June 2025 for the commitment to fulfill its potential.

# **Section I: Action Plan Refresh**

No commitments were added or significantly amended in Jordan's refreshed national action plan (NAP). Milestones were added under four commitments that increase civil society's involvement in implementation. While positive, these new activities build on existing milestones and therefore do not notably change commitments' level of ambition.

New milestones added to Commitments 1, 2, 4, and 5 increase opportunities for government and civil society to carry out reforms collaboratively.

- Commitment 1 seeks to strengthen the financial accountability of civil society organizations (CSOs) to address Financial Action Task Force (FATF) recommendations. Three milestones were added to institutionalize good governance practices within CSOs through voluntary policies and manuals. New milestones will be implemented in collaboration with CSOs specialized in integrity and transparency. Challenges in the existing partnership between government and CSOs will be assessed and an action plan to address these challenges will be developed.<sup>1</sup>
- **Commitment 2** on e-participation in decision-making has two new milestones aimed at increasing CSO engagement. These include building CSOs' capacity on global standards for e-participation and forming an alliance with CSOs to promote the use of the unified platform developed under this commitment.
- **Commitment 4** on youth participation has three new milestones, all related to the virtual youth center.
- **Commitment 5** on enhancing integrity at the national level adds two new milestones aimed at increasing CSOs' role in developing good governance practices and expanding CSO outreach at local level.

These new milestones were identified through a participatory process. At the beginning of the refresh process, OGU posted a public call on Jordan's OGP website and the ministry's social media platforms for new commitment and milestones proposals.<sup>2</sup> OGU categorized and presented the proposals to the NAP Focal Point Committee,<sup>3</sup> comprising all government agencies involved in implementation. OGU held a workshop for all individuals and organizations who submitted suggestions and CSOs who participated in the development of the fifth NAP. During the workshop, a joint working group of government focal points and CSO representatives for each commitment reviewed and finalized the new milestones.<sup>4</sup> OGU then posted outputs of the refresh process, including the refreshed NAP, on Jordan's OGP website.<sup>5</sup>

OGU responded by email to individuals and CSOs who submitted 9 proposals for the refreshed action plan.<sup>6</sup> However, It was decided not to add commitments or make major changes as cocreation for the sixth NAP was expected to commence within less than a year after the refresh in 2025.<sup>7</sup> OGU shared suggestions that were not included in the refreshed NAP with the relevant government agencies for consideration in other plans.<sup>8</sup>

Some suggestions were not adopted as they were being addressed elsewhere, such as a proposal to address violence against women, particularly election violence, cyber harassment, and bullying during election period. The Independent Election Commission has a hotline dealing with election complaints and has a gender component in its outreach activities. Another suggestion requested the appointment of one government point of reference for CSO registration instead of two (Registry of Societies and Companies Control Department). This

suggestion requires legislative amendment, which is currently being undertaken by a designated committee.<sup>10</sup> Finally, a suggestion to establish a training institute for CSOs was not added for lack of funding but will be considered in the future.

## **Section II: Implementation Update**

This section provides an overview of the implementation status of the action plan at the midpoint. It is based on information available online or, if necessary, on evidence provided by key stakeholders. It includes commitments identified as promising in the Action Plan Review, submitted under the Open Gov Challenge, or where there is notable evidence of progress online. This is not an assessment of completion or early results, which the IRM will carry out in the Results Report at the end of the implementation period.

All six commitments were at an advanced level of implementation as of October 2024, with all milestones either completed or underway. Jordan's OGP website includes articles on individual milestones, including invitations to bid,<sup>4</sup> policy documents,<sup>5</sup> and workshops.<sup>6</sup> In addition, information on commitments are covered by local news websites<sup>7</sup> and TV stations.<sup>8</sup> Positively, OGU has engaged civil society in carrying out milestones through posting opportunities to participate on Jordan's OGP website, and utilizing social media, an email list of 420 organizations, and WhatsApp for wider outreach.<sup>9</sup> OGU has also held CSO consultation and outreach activities outside the capital.<sup>10</sup> One main challenge at the beginning of implementation was a lack of sufficient funding to develop the interactive online virtual youth center (Commitment 4) and accountability training (Commitment 5) platforms.<sup>11</sup> Funding for the virtual youth center was later secured while funding for the accountability training platform was still pending at the time of review.<sup>12</sup>

Implementation of Commitments 3 and 6, which were identified as promising in IRM Action Plan Review, are underway. Commitment 3 seeks to mainstream gender consideration across public sector policies, strategies, and planning. The target number of five gender audits under Commitment 3 has been met and three additional ministries were added. Gender Units in the five ministries were trained and are following up on audit action plans. Work is ongoing on a policy compliance system to encourage gender mainstreaming in the public and private sectors. Commitment 6 seeks to establish participatory approaches to public capital investment projects. Methodologies and training to engage local stakeholders in the design and impact assessment of investment projects were completed. However, the last milestone on implementing mechanisms for participation was still not achieved. No projects were piloted to test methodologies at the time of writing. According to OGU, three projects are being considered, including a project on the environment.

## **Section III: Participation & Co-Creation**

The IRM uses the OGP Participation and Co-Creations Standards to assess countries' participatory practices throughout the action plan cycle. Countries are encouraged to aim for the full ambition of the standards and to meet the minimum requirements.
