- The data available has not met the national's quality data principles and may lead to misinterpretation among the data users.
- Data management regulation has not been completed yet and does not include several stakeholders.
- West Nusa Tenggara Government already own an information system for regional development data publication named Satu Data NTB (West Nusa Tenggara One Data) portal. Nevertheless, the system is not integrated with geospatial data system and district/city data system.
- Human resource quality for data management in regional offices is not optimal because of inadequacy of data management capability and the rolling of human resource role as data officer.
- The continuity of data collected by the regional offices may be not maintained.
- The list of data needed to support development program has not been completed yet because the data architecture is not available.
- Local data forum and data collection may be not held by several district/city governments.

7. Status quo

- Satu Data NTB is held based on the mutual agreement between the government agencies involved about Regional Development Data and Information Management towards West Nusa Tenggara One Data.
- Up to July of 2021, Communication, Informatics, and Statistics Office has collected data from other offices of West Nusa Tenggara Government as data producer; 917 of 964 data has been collected (around 95.12%) and 902 of 964 data has been published (around 93.57%).
- Data forum has been created, involving data entry staff from each regional office of West Nusa Tenggara Government and Central Bureau of Statistics of West Nusa Tenggara Province as data quality advisor.
- The information system for regional development data publication has been established. The system implements the concepts of open data and can be accessed by public in https://data.ntbprov.go.id.

- Satu Data NTB program has been implemented by West Nusa Tenggara Province Government since 2017, two years before the release of Satu Data Indonesia (Indonesia One Data) Presidential Regulation.
- Since 2018-2021 the number of data published through the portal is more than 2000 datasets which are grouped into 3 sectors, namely social, economic and infrastructure. The data is collected from all regional offices within the West Nusa Tenggara Province Government.
- One Data NTB program is in line with and supports the National One Data Indonesia policy as stated in Presidential Regulation Number 39 of 2019 concerning Satu Data Indonesia.
